

Request form for the exercise of personal data rights TTW Public Company Limited and its subsidiaries

The Personal Data Protection Act, B.E. 2562 grants the data subject the following rights with respect to his or her personal data:

- 1. Right to withdraw consent if consent has been given to the collection, use or disclosure of personal data.
- 2. Right to request access and/or obtain a copy of personal data.
- 3. Right to request the transfer of personal data.
- 4. Right to object to the collection, use or disclosure of personal data.
- 5. Right to request to delete or destroy or make personal data to be anonymized
- 6. Right to request to suspend the use of personal data.
- 7. Right to request that personal data be updated so that it is accurate, complete, and does not cause confusion.

However, if you find that the company Violate or fail to comply with the law, you can complaint to competent officials under the Personal Data Protection Act B.E. 2562 (2019)

When the company receives the request form and supporting documents, it will verify their accuracy and will respond to your inquiry within 30 days. However, the company might not be able to accommodate your request. Such a request will be denied if it is illegal or violates on the company's reserved rights.

Required documents

- 1. Form for requesting the exercise of personal data rights
- 2. ID card or passport photocopy (In case the person requesting personal data is a foreigner)
- 3. Power of Attorney and a copy of the authorized person's and attorney's identification cards (In case the owner of the personal data does not do this by themself)

4. Company reserves the rights

- 4.1 The Companies may deny your request in the following situations:
- (1) If you cannot prove that you are the owner of the requested personal data or provide insufficient information or refuse to cooperate when the companies requests additional information.
- (2) To perform duties for the public interest or to comply with the law or a court order and your request to exercise your rights will have a negative impact on the freedoms and rights of others.
- (3) When you object to the processing of personal data and the Companies can show that the processing of personal data is justified by more compelling legitimate interests or to establish legal claims, legal compliance, or legal defenses
- (4) Storing that personal data for the purpose of exercising freedom of expression or for the purpose of documenting history or archives for the public benefit or related to research studies or statistics, which provide appropriate safeguards to protect the rights and freedoms of data subjects, or is necessary for the performance of duties in carrying out the mission for the public interest of the company or performing duties in exercising state powers conferred on the companies or occupational medicine or public health advantages such as protection from serious communicable illnesses or epidemics, as specified in Section 26 (5)(a)(b) of the Personal Data Protection Act B.E. 2562.
- 4.2 The Companies will not charge you for the processing of your request unless it determines that it is excessive, repetitive, or unreasonable. The operating expenses of the company are reasonable. The company will collect reasonable operating cost.
- 4.3 If the Organization denies your request, the company will notify you via registered mail or the email address you provided in Section 4.1.
